If any or all of these vehicles remain on the above property after the deadline date shown, they will be removed by the City of Fargo. Junked vehicles removed by the City will be disposed of immediately.

If you fail to correct the violation by the stated deadline this office may file a Summons and Complaint against you, requiring you to appear in Municipal Court. **This is your notice to correct the violation.**
